Dear Dr. Shuman,

The Pacific States Marine Fisheries Commission (Commission) has received notification for the appropriation of funds for fisheries disaster assistance through the 2023 Disaster Relief Supplemental Appropriations Act (P.L. 117-328) and under the Extending Government Funding and Delivering Emergency Assistance Act, 2022. On January 29, 2024, NOAA allocated \$11,930,140 of these funds to respond to the impacts of the 2017 and 2019 Muckleshoot Indian Tribe Coho, Chum, and Pink Salmon Fisheries, 2020 Yurok Tribe Chinook Salmon Fisheries, 2018, 2019, 2020 Oregon Chinook Salmon Fisheries, 2018 and 2019 Northern Management Zone California Red Sea Urchin Fisheries, and the 2022 Alaska Yukon River Salmon Fishery disasters. Funds were allocated based on fishing revenue losses and negative Tribal subsistence fishery impacts. \$1,648,366 was allocated to respond to the following disaster:

Funds will be deducted for the Commission to administer this relief and are based on our anticipated level of effort; funds will be capped at 1% (\$16,484).

The Commission is requesting information from the State of California so that we can prepare the grant application for these funds. Funds can be used to address a range of impacts including impacts to commercial fishermen, recreational fishermen, charter businesses, subsistence users, processors, shore-side infrastructure, and the fishing ecosystem and environment. These funds should be used for activities that restore the fishery or prevent a similar failure in the future and assist fishing communities affected by such failure. NOAA strongly recommends that recipients utilize these funds to strengthen the long-term economic and environmental sustainability of the fishery.

This can include, but is not limited to, activities such as habitat restoration, research, state-run buybacks, job retraining, and fishery-related infrastructure.

Below is a summary of what we need from your entity, the timelines, and what these funds can or cannot be used for.

1. A spend plan (statement of work and detailed budget) outlining what the funds will be used for.

Describe the main categories for funding as applicable (habitat restoration, research, buybacks, job retraining, and fishery-related infrastructure) that restore the fishery or prevent a similar failure in the future and assist fishing communities affected by each failure. Describe the work to be performed, approach to complete the work, and timelines for the work.

2. The performance period for these funds will be January 1st, 2025 through December 31st, 2029. All work must be performed or expenses incurred during this timeframe. **No work or expenses can occur prior to this date. Work and expenses should not begin until your entity is notified of the approved start date of these funds.**
3. These disaster funds cannot be used on the following: cost share or match to any other funds (federal or non-federal); land purchases; loan programs; losses already covered by insurance; or specific grant-related activities for which Federal or other funds have been received.
4. Funds may be expended for administrative processes, for the purpose of economic analyses that may be necessary for a detailed spend plan.
5. Depending on activities proposed, NEPA review may be required.

If proposing to use funds for direct payments to fishers, businesses, etc., you must include a justification addressing the following:

- Why direct payments, instead of long-term economic and environmental measures, are the best mechanism to address the fishery disaster, and describe the anticipated economic impact on the local fishing community.
- Describe how you will determine who is eligible for direct payments and verify their eligibility.
- Describe how you will determine the disbursement amounts of direct payments.
- Describe the appeals process and how you will determine if an appeal is granted or not.
- Payments may not be provided directly to minors.
